

**SUPPLEMENTAL RULES FOR THE “MYSTERY MULTIPLIER”  
MILLION DOLLAR REPLAY PROMOTION  
Effective September 01, 2021**

The New Jersey Lottery is conducting a supplemental Mystery Multiplier Million Dollar Replay promotion (“Mystery Multiplier Promotion”) whereby players who enter any of the eligible non-winning \$5 or \$10 Scratch-Offs tickets into Million Dollar Replay are eligible to multiply the value of their non-winning ticket. The Promotion is governed by these Supplemental Official Rules for Mystery Multiplier Promotion (“Supplemental Official Rules”).

To participate in the Promotion, players must have already registered as a New Jersey VIP Club Member by downloading the New Jersey Lottery app or by visiting NJLottery.com/VIPClub. For Registration details, visit <https://www.NJLottery.com/VIPCLUB>

1. The Promotion Period for the Mystery Multiplier Promotion is January 4, 2021 – December 31, 2021.
2. During the Promotion Period, players (sometimes referred to as “you” or “your”) who enter an Eligible non-winning \$5 or \$10 Scratch-Off ticket will multiply the value of their non-winning ticket by a pre-determined value of either 2X (times), 4X (times), 6X (times), 8X (times) or 10X (times) and receive an increased value into the applicable quarterly Million Dollar Replay drawing.

A list of Eligible non-winning \$5 or \$10 Scratch-Offs follows and is subject to change and will be updated monthly in accordance with the new \$5 or \$10 Scratch-Offs game launch and posted in the Supplemental Official Rules and on NJLottery.com:

3. Players must be 18 years or older to play and participate in the Mystery Multiplier Promotion. Persons prohibited from purchasing New Jersey Lottery tickets or shares pursuant to N.J.A.C. 5:9-16 and N.J.A.C. 17:20-1.3 are prohibited from playing or participating in the Mystery Multiplier Promotion.
4. The New Jersey Lottery may declare any Eligible non-winning \$5 or \$10 Scratch-Off ticket purchased during the Promotion Period void if it is stolen.
5. Licensed New Jersey Lottery retailers are not eligible to participate in the Mystery Multiplier Promotion.
6. The New Jersey Lottery reserves the right, without prior notice, to cancel, terminate, modify or suspend the Mystery Multiplier Promotion at any time and for any reason, including but not limited to if the New Jersey Lottery determines that a virus, bug, unauthorized human intervention, fraud or other cause beyond its control has or is corrupting or affecting the administration, security, fairness or proper conduct of the Mystery Multiplier Promotion.
7. By playing or participating in the Mystery Multiplier Promotion, you hereby agree to (a) be bound by these Supplemental Official Rules and the 2021 Official Million Dollar Rules; (b) forever waive, release and discharge any and all claims and causes of action which you or your heirs, agents, representatives, executors, administrators, or any other persons acting on your behalf or on behalf of your estate have or may have against the New Jersey Lottery and/or Northstar New Jersey Lottery Group, LLC and its/their respective agents, owners, operators, officers, directors, elected officials, members, shareholders, managers, contractors, subcontractors, employees, partners, and designees and each of its/their respective parent companies, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, commissioners, and any and all other companies associated with the New Jersey Lottery and/or Northstar New Jersey Lottery Group, LLC; and (c) forever waive, release and discharge the New Jersey Lottery and/or Northstar New Jersey Lottery Group, LLC and its/their respective agents, owners, operators, officers, directors, elected officials, members, shareholders, managers, contractors, subcontractors, employees, partners, and designees and each of its/their respective parent companies, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, commissioners, and any and all other companies associated with the New Jersey Lottery and/or Northstar New Jersey Lottery Group,

LLC, from any and all liability, injury, damage, death, loss, litigation, claim, cause of action and/or damage that may occur, directly or indirectly, whether caused by negligence or not, from (i) your participation, in whole or in part in the Mystery Multiplier Promotion; (ii) your acceptance, possession, use, or misuse of any prize awarded in connection with the Mystery Multiplier Promotion; (iii) technical failures of any kind, including but not limited to the malfunctioning of any computer, cable, network, hardware or software in connection with the Mystery Multiplier Promotion; (iv) the unavailability or inaccessibility of any transmissions or telephone or Internet service during the Promotion Period; (v) unauthorized human intervention in any part of the Mystery Multiplier Promotion; and (vi) electronic or human error which may occur in the administration of the Mystery Multiplier Promotion.

8. By playing or participating in the Mystery Multiplier Promotion, you hereby irrevocably consent to the use and/or publication of your name, hometown, photograph(s), image, voice, and/or likeness by the New Jersey Lottery and/or its designee in any and all of its online, printed and social media advertisements, promotions, publications, illustrations, and other Web content throughout the world in perpetuity, including but not limited to, on the World Wide Web, without payment or any other consideration to you. You hereby irrevocably authorize the New Jersey Lottery or its designee to edit, alter, copy, exhibit, publish and/or distribute, without any inspection or approval of use by you, your name, hometown, photograph(s), image, voice, and/or likeness for purposes of publicizing the New Jersey Lottery or for any other lawful purpose. In addition, you hereby irrevocably waive any right to royalties or other compensation arising from or related to the use and/or publication of your name, hometown, photograph(s), voice, and/or likeness. You acknowledge that the New Jersey Lottery Law allows the holders of winning New Jersey Lottery tickets or shares to choose to remain anonymous and you acknowledge that this does not apply to the Mystery Multiplier Promotion.
9. By participating in the Mystery Multiplier Promotion, you agree to fully comply with these Supplemental Official Rules and the 2021 Official Million Dollar Replay Rules, and to accept the decisions of the New Jersey Lottery or its designee as final and binding with regard to the Mystery Multiplier Promotion. The Mystery Multiplier Promotion is governed by the State Lottery Law, N.J.S.A. 5:9-1 through -25, and the Rules of the Lottery Commission, N.J.A.C. 17:20-1.1 through -12.23. The New Jersey Lottery Executive Director has the sole authority to resolve disputes. The New Jersey Lottery Executive Director's decision regarding any disputes shall be final.
10. These Supplemental Official Rules may be changed at any time without prior notice if determined by the New Jersey Lottery or its designee to be in the best interests of the New Jersey Lottery.
11. All winners, tickets and transactions in connection with the Mystery Multiplier Promotion are subject to New Jersey Lottery Rules and Regulations and State law. All prizes awarded in connection with the Mystery Multiplier Promotion may be subject to claim procedures, validation tests and other applicable requirements of the New Jersey Lottery. Liability for void or nonconforming ticket, if any, is limited to replacement of ticket with un-played ticket. The New Jersey Lottery is not responsible for lost or stolen tickets. The Mystery Multiplier Promotion is void where otherwise prohibited by law. Mystery Multiplier Promotion not valid in combination with any other New Jersey Lottery promotion or coupon.

The invalidity or unenforceability of any provision of these Supplemental Official Rules will not affect the validity or enforceability of any other provision of these Supplemental Official Rules. In the event that any provision of these Supplemental Official Rules is determined to be invalid or otherwise unenforceable or illegal, in whole or in part, the other provisions will remain in full force and effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained therein. The failure to enforce any provision of these Supplemental Official Rules will not constitute a waiver of that or any other provision of these Supplemental Official Rules.
